CIRCULAR

All the employers/HOD's//MS/MD of Hospitals/Clinic/Nursing Homes/Nursing Institutes/Dispensary/ Health Centre etc. of Nurse, Midwife, ANM and MPHWH that the registration and renewal of registration of all the nurses working in the NCT of Delhi is mandatory vide DNC Act 1997 under section:

For Registration (Section 17): "Persons not registered or not in the list not to practice or be employed as nurses, etc.- No person other than a person registered-under this Act or person whose name is entered in the list under section 16 shall practice directly or by implication as practicing habitually or for personal gains as a nurse."

For Renewal (Section 21): "Every person registered' under this Act who intends to practice anywhere in the National Capital Territory, of Delhi as a nurse, auxiliary nurse-midwife, female health worker, female health assistant/health supervisor, shall give notice in writing to the licensing authority every five years thereafter during the period if he continues to practise within the said area."

As per guidelines for renewal of registration the applicant must obtain credit hours by attending professional Continue Nursing Education (CNE). A Nurse must earn 30 credit hours in a year, accumulated to 150 credit hours over a period of 5 years which are required for renewal of DNC registration every 5 years.

All employees are suggested to develop CNE Cell in your institute from upgrading knowledge and nursing skills enabling nurses to provide quality patient care and meet the criteria of renewal of their registration at Delhi Nursing Council.

All the employers/HOD's//MS/MD of Hospitals/Clinic/Nursing Homes/Nursing Institutes/Dispensary/ Health Centre etc. of Nurse, Midwife, ANM and MPHWP that the registration and renewal of registration of all the nurses working in the NCT of Delhi is mandatory vide DNC Act 1997 under section:

For Registration (Section 17): "Persons not registered or not in the list not to practice or be employed as nurses, etc.- No person other than a person registered-under this Act or person whose name is entered in the list under section 16 shall practice directly or by implication as practicing habitually or for personal gains as a nurse."

For Renewal (Section 21): "Every person registered under this Act who intends to practice anywhere in the National Capital Territory, of Delhi as a nurse, auxiliary nurse-midwife, female health worker, female health assistant/health supervisor, shall give notice in writing to the licensing authority every five years thereafter during the period if he continues to practise within the said area."

As per guidelines for renewal of registration the applicant must obtain credit hours by attending professional Continue Nursing Education (CNE). A Nurse must earn 30 credit hours in a year, accumulated to 150 credit hours over a period of 5 years which are required for renewal of DNC registration every 5 years.

C I R C U L A R

As you are aware that with the development in Medical Science and Technological Advances, the nursing profession has also undergone many changes. With the enforcement of Consumer Protection Act, it is becoming mandatory for practicing nurses to keep themselves updated with recent advances in nursing/medical sciences and technological developments.

As per the discussion held in Registrar's meeting held on 11.11.09 and 12.11.09 in the Ministry of health, Govt. of India under the chairmanship of the Nursing Advisor to Govt. of India, Mr. T. Dileep Kumar, it is decided to link renewal of Registration with "CREDIT HOURS" acquired by means of attending workshops, seminars, conferences and / or continuing education Programmes.

Keeping this in view, the Delhi Nursing Council is introducing renewal of registration based on the "Credit Hours" acquired by attending workshops, seminars, conferences and/or continuing education programmes.

Renewal of registration will be done for five years based on acquisition of 30 credit hours per year (i.e.150 credit hours for 5 years) and payment of Rs.500/- as fees for RNRM and Rs. 200/- for ANM/MPHW (F). The candidates requesting for renewal will have to produce a True Photocopy of certificates of continuing education programmes or workshops, seminars and conferences attended.

Therefore, the concerned authorities are hereby directed to depute and relieve nurses working under their administration, for attending seminars, workshops/conferences and /or continuing education programmes to help them acquire credit hours for renewal of registration.

CIRCULAR

Consequent upon to the implementation of the Delhi Nursing Council Act, 1997 (Act No. 3 of 1999) w.e.f. June 2001 it is informed that registration with Delhi Nursing Council is compulsory **Under Section 13 (1), 14.**

The Medical Superintendent, Director (Admn.), Chief Medical Officers, Nursing Superintendent, are hereby informed that any nursing personnel (regular/on contract/adhoc) working in the various departments of the Hospital, Schools, Colleges, Clinic, Nursing Home, any health establishment without having registration with Delhi Nursing Council are liable to be treated as unlawful **Under Section 28.** It is also brought to the notice that the recognition of the training that the personnel has undergone shall be confirmed and ascertained with Delhi Nursing Council before employing/joining of the candidate to the job. Employing any nursing personnel who does not possess the minimum requisite qualification laid down shall, on conviction, be punished under Sub-Section (5) of Section 26.

The recognized qualifications for registration **Under Section 13** of Delhi Nursing Council Act are as follows. **No other qualification or title whatsoever is recognized by Delhi Nursing Council**

- ♦ **Nurse:** Means a person who possesses a four-year B.Sc.(Hons.) in Nursing (degree course) or General Nursing and Midwifery (GNM certificate course) of three or three and half years duration from an institution in this behalf recognized by Indian Nursing Council and registered with Delhi Nursing Council.
- ♦ **Auxiliary Nurse Midwife/Multipurpose Health Worker (Female)/Female Health Worker/Female Health Assistant or Supervisor:** Means a person who possesses a certificate of Auxiliary Nurse Midwife, (18 months or 24 months) with or without six months supervisory course or, as the case may be from an institution recognized by Indian Nursing Council and registered with Delhi Nursing Council.

All the nurses trained in Delhi, registered with Punjab Nurses Registration Council/or any other state nursing council in India and employed in Delhi require to re-register with Delhi Nursing Council after observing the prescribed procedure. The application forms can be obtained from the office of the Delhi Nursing Council between **10.00 A.M. to 1.00 P.M. on all week days (Monday to Friday) except holidays.**
